Recently, Generator Unit 2 of China Energy Guangtou Beihai Power Generation Co., Ltd. ("**Beihai Power Plant**"), a 52% holding subsidiary of the Company, has successfully passed the 168-hour trial operation test and been officially delivered for commercial operation. So far, two 1,000 MW ultra-supercritical coal-fired generator units of the Phase I project of Beihai Power Plant have been completed and put into operation.

Beihai Power Plant, which is located in Tieshan'gang Industrial Park, Beihai City, Guangxi Zhuang Autonomous Region ("Guangxi"), is a key coal-fired power project set out in the 14th Five-Year Plan for energy development of Guangxi. The Phase I project of Beihai Power Plant has adopted domestic advanced high-capacity and high-parameter secondary reheat coal-fired power generator units with a designed coal consumption of 262.89g/kWh, and the power generation efficiency has reached the first-class level of domestic coal-fired power generator units. The two units in the Phase I project of Beihai Power Plant are expected to generate 11 billion kWh of electricity annually, which will further meet the demand for the growth of power load in Guangxi and provide important support and guarantee for ensuring energy security, economic and social development in the Beibu Gulf.
