Note: The Company has completed the transactions involving the issuance of shares and payment of cash to acquire the relevant assets of the controlling shareholder, China Energy Investment Corporation Limited. From April 2026, the Company's major operational data includes the business volumes of the newly consolidated assets. To maintain data comparability, the Company has made retrospective adjustments to the major operational data for the corresponding period last year.

In May 2026, the year-on-year increase in coal sales was mainly due to the growth in sales volume of purchased coal and the relatively low base in the same period last year. The year-on-year decrease in polyethylene sales was mainly affected by factors such as production plans and changes in market conditions.

The major operational data above was calculated based on the internal statistics of the Company. Operational data may show major differences from month to month. The factors giving rise to such differences include, among others, changes in weather, equipment overhaul, seasonal factors and safety inspection. The major operational data may somewhat differ from the data disclosed in the relative periodic reports. Investors are hereby reminded of the risks that may result from inappropriate reliance upon or utilization of the information given above.
